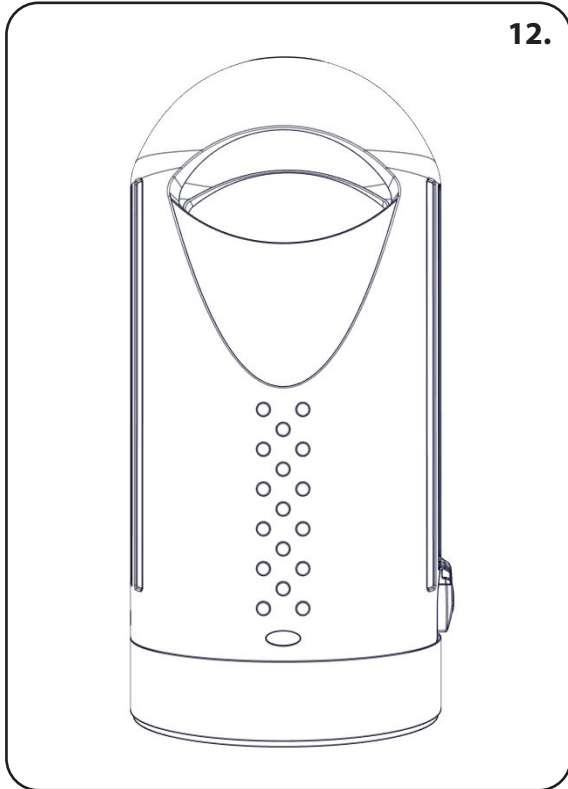
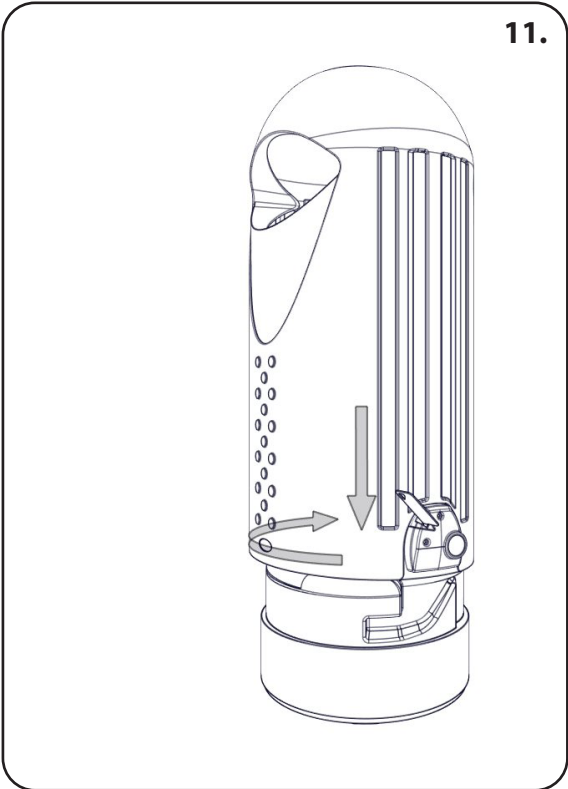
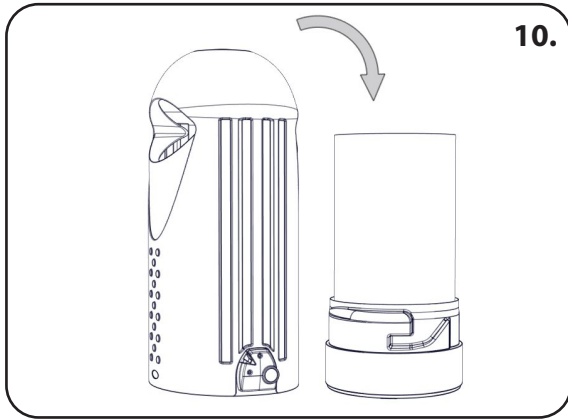
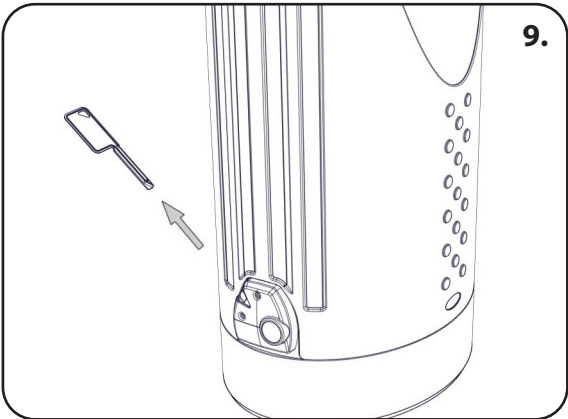
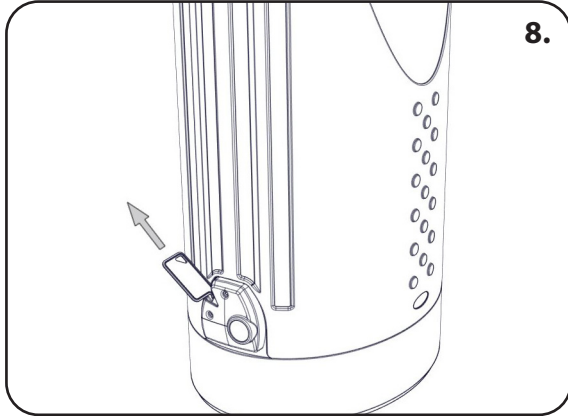
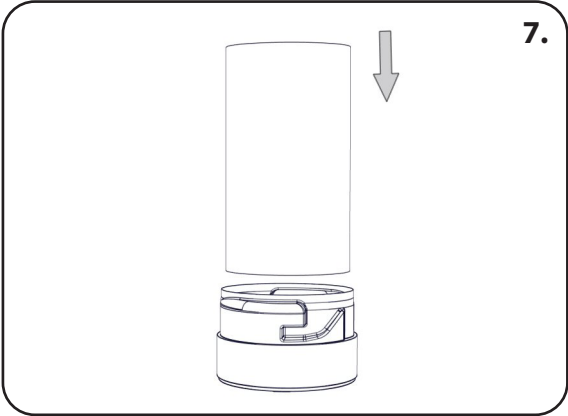
We recommend that a risk assessment is undertaken to identify an appropriate location for your waste collection and recycling units.

PRODUCT MAINTENANCE

CLEANING

We would recommend a warm pressure wash with soap or alternatively hand wash with 10% solution of mild detergent in warm water using a soft bristle brush followed by a rinse with clean water.

GRAFFITI

Felt tip pen or paint may be removed from the Armortec coated steel parts using a proprietary graffiti remover. Carefully follow the instructions, particularly the guidelines covering safety. Ensure that all traces of chemicals are removed then clean as detailed above.

MAINTENANCE

A planned maintenance schedule of regular inspection is recommended and components replaced when necessary.
